TERMS AND CONDITIONS OF ENTRY

1. All traders must have a public liability insurance policy with a value not less than £2 million in place. All drivers must have the appropriate licence to operate the vehicle in their charge. Please bring evidence of the above for inspection at the time of the event.
2. On show days, all traders must be in place and set up by no later than 10am. No trader to leave site before 5pm regardless of weather conditions. No entry to traders that arrive after 11am. These will be charged full admission price and be parked in the public car parking area. There is no motor vehicle movement on site between 10:30am and 5pm.
3. All exhibitors attend entirely at their own risk and the land owner and organisers cannot be held accountable in any circumstances for any injury loss or damage however caused!
4. There is no access to the Event site before 12noon Thursday 12th September and all items must be removed by 5pm on Monday 16th September UNLESS by Prior arrangement (please use the contact details on entry form)
5. The show operates under the same rules as the public highway, and offenses will be treated accordingly. No machinery or vehicle of any nature to be operated by people under the influence of alcohol or drugs. There is a maximum speed limit of 5 mph on the entire site.
6. All generators to be turned off no later than 10:30pm. Absolutely no ground level barbecues or fires at any time.
7. The safety officer reserves the right to shut down, remove or stop any vehicle/exhibit/act/machine that they consider to be unsafe and dangerous or a nuisance to other fair attendees.
8. The event organisers uphold their right to refuse entry to, or eject any persons from, the event site should an issue arise. Please do not park on the grassed areas surrounding the site, vehicles found parked in these will be removed! The event organizers uphold their right to cancel the event without prior notice to exhibitors.
9. Each entry will be sent passes to admit 2 adults. Under 16's free. Each entry shall be entitled to ONE vehicle pass.. Only those with a pass shall be able to gain free entry to the event site.
10. The event organisers uphold their right to cancel the event without prior notice to exhibitors.
11. In any dispute the organisers word is final.
