1. The Event is open to the public from 10am to 4pm and set up is available from 6.30am on the day.
2. All sites and stalls must be staffed, stocked and open to the public by 10am to 4pm on the show day.
3. All vehicles to be removed from the show area by 9am, no unloading permitted after 9am.
4. ALL Exhibitors and trade vehicles must be parked in the designated parking area by 9am.
5. No vehicle movement allowed on site during the hours of 10am and 4pm.
6. No stall should be dismantled before 4pm.
7. Set up on Friday is available, please contact the events office to arrange.
8. No stand is secure until the payment is cleared.
9. Your payment must be made in full at the time of booking.
10. If an exhibitor cancels a booking, for whatever reason they shall forfeit any fees paid to Stonham Barns.
11. Stonham Barns Ltd has taken reasonable precautions to ensure the health & safety of everyone present for the event. For these measure to be effective, please take reasonable precautions to avoid and prevent accidents occurring by removing obstacles which may cause tripping, falling or equipment/goods falling onto people and adhering to the guidelines of the show and its officials.
