TERMS AND CONDITIONS OF ENTRY

- 1. All exhibits must have a public liability insurance policy with a value not less than £2 million in place. All steam boilers and pressure vessels to have a valid boiler certificate and boiler explosion and fire and sparks insurance. All vehicles must have adequate RTA insurance. All operators must have the appropriate licence to operate the vehicle in their charge. Please bring evidence of the above (i.e. paperwork or NTET disc) for inspection at the time of the event.
- 2. All exhibitors must agree to follow all reasonable requests by the event stewards, and parade in ring events if so requested. If you are unable to attend for any reason, please let us know ASAP. Failure to attend without giving notice may result in not being invited the following year.
- 3. On show days, all exhibits must be in place and set up by no later than 10am. No exhibit to leave site before 4pm regardless of weather conditions. No entry to exhibits that arrive after 11am. These will be charged full admission price and be parked in the public car parking area. There is no motor vehicle movement on site between 10:30am and 4pm. Steam powered vehicles are encouraged to drive around the event site but are asked NOT to drive around the trade stand areas.
- 4. All exhibitors attend entirely at their own risk and the landowner and organizers cannot be held accountable in any circumstances for any injury loss or damage however caused!
- 5. There is no access to the Event site before 12 noon on Friday 17th May 2024 and all items must be removed by 5pm on Monday 20th May 2024 **UNLESS** by prior arrangement (please use the contact details on entry form)
- 6. The show operates under the same rules as the public highway, and offenses will be treated accordingly. No machinery or vehicle of any nature to be operated by people under the influence of alcohol or drugs. There is a maximum speed limit of 5 mph on the entire site.
- 7. No item to be placed for sale without the prior consent of the organizer, there may be a charge for doing so.
- 8. All generators to be turned off no later than 10:30pm. Absolutely no ground level barbecues or fires at any time.
- 9. The safety officer reserves the right to shut down, remove or stop any vehicle/exhibit/act/machine that they consider to be unsafe and dangerous or a nuisance to other show attendees.
- 10. The event organizers uphold their right to refuse entry to, or eject any persons from, the event site should an issue arise. Please do not park on the grassed areas surrounding the site, vehicles found parked in these will be removed! The event organizers uphold their right to cancel the event without prior notice to exhibitors.
- 11. On arrival, each entry will be given passes to admit 2 adults. Under 15's free. Each entry shall be entitled to ONE Caravan pass. Only those with a pass shall gain free entry to the event site.
